

Terms and Conditions

1. Acceptance of Terms

By accessing or using the VibeLink Enterprises Inc. application or site or services (jointly referred as to the “App”), you agree to be bound by these Terms and Conditions (“Terms”). The use by you of the App and/or certain services accessible through the App may be subject to your acceptance of separate agreements with us or any other third parties.

PLEASE READ THESE TERMS CAREFULLY. BY USING THE SERVICES AND/OR ACCEPTING THESE TERMS BY CLICKING “I ACCEPT” OR SIMILAR ATTESTATION, YOU AGREE TO THESE TERMS OF USE. IF YOU DO NOT AGREE TO THESE TERMS OF USE, YOU MUST EXIT THE SERVICES IMMEDIATELY AND DISCONTINUE ANY USE OF THE SAME.

2. Description of Services

The App provides a platform for university students in the U.S. to discover campus clubs and events, connect with peers through chats and profiles, access organization resources like documents and media, participate in events via RSVPs and check-ins, and manage club memberships and leadership. Club leaders can verify and administer their organizations, create events, moderate content, and handle attendance and permissions, all while using built-in safety tools like reporting, blocking, and notification controls.

3. User Eligibility

You must be at least 18 years old to use the App. By accessing or using the App, you represent and warrant that you are at least eighteen (18) years old and have the legal capacity to enter into these Terms.

The App is intended for university and college students and other eligible adult users. VibeLink does not knowingly permit individuals under eighteen (18) years of age to register for or use the App. If we learn that an individual under eighteen (18) has registered or that we have collected personal information from an individual under eighteen (18), we may deactivate the account and take reasonable measures to delete the individual's personal information, subject to applicable law and legitimate legal, security, or safety requirements.

If you believe that an individual under eighteen (18) has registered for or is using the App, please contact us using the contact information provided in these Terms.

4. Account Registration and User Content

To access certain features, you must register for an account. You agree to provide accurate and complete information and to keep this information up to date. If you decline to create an account, this may interfere with or prevent your further use of the App.

You must not share your login credentials or password with anyone else. If a third party does gain access to your account, you will be responsible for all use of your account by that person, whether authorized or unauthorized. We reserve the right to suspend or terminate your account separate from the suspension or termination of these Terms. Accounts may be suspended or terminated for failure to comply with these Terms, violation of third-party intellectual property rights, violation of third-party privacy rights, suspected illegal activity, or if we believe that your account has been compromised in any manner.

5. User Conduct and User Content

You agree not to:

- Use the App for any unlawful purpose.
- Impersonate any person or entity.
- Interfere with or disrupt the App or servers.
- Upload or transmit viruses or harmful code.

By submitting, uploading, transmitting, or making available through the App any data, content, or materials (“User Content”), you represent and warrant that: (i) you own or have obtained all rights necessary to submit, upload, transmit, or make available such User Content and to use it for your intended purposes; (ii) The User Content you submit, your use of such User Content, and our use of such User Content as set forth in these Terms do not and will not: (a) infringe, misappropriate, or violate any patents, copyrights, trademarks, trade secrets, or other intellectual property rights, or any proprietary, privacy, data protection, or publicity rights of any third party; or (b) violate any applicable local, state, federal, or international laws, regulations, or conventions, including those relating to data privacy, data protection, and data transfer or export.

You also agree not to post, upload, transmit, or otherwise make available any content that is false, deceptive, misleading, defamatory, obscene, threatening, libelous, harassing, degrading, intimidating, or hateful toward any individual or group based on religion, gender, sexual orientation, race, ethnicity, age, or disability. Additionally, you agree not to post content that contains software viruses, political campaigning, chain letters, mass mailings, or any form of “spam” or unsolicited commercial electronic messages.

You are solely responsible for your User Content and assume all risks associated with its use, including any reliance on its accuracy, completeness, or usefulness by others, or any disclosure of your User Content that makes you or any third party personally identifiable. VibeLink Enterprises Inc. assumes no responsibility and no liability for any User Content posted by you or any third party. Any User Content you post will be considered non-confidential. VibeLink Enterprises Inc. reserves the right, but not the obligation, to monitor, edit, or remove any User Content at its discretion.

By making any User Content available through the App, you hereby grant VibeLink Enterprises Inc. a non-exclusive, transferable, sub-licensable, worldwide, perpetual, irrevocable, paid-up, royalty-free license to use, copy, modify, aggregate, create derivative works of, distribute, publicly display, publicly perform, and otherwise fully exploit your User Content in connection with the App and our business operations, including, but not limited to, promoting and redistributing part or all of the App in any media and through any media channels, even after the termination of your account or the App.

VibeLink Enterprises Inc. shall own all such de-identified data sets, and all products, solutions, and services created using the data sets, including all intellectual property rights related to such data sets and derivative works.

You further grant each user of the App a non-exclusive, perpetual license to access, use, edit, modify, reproduce, distribute, prepare derivative works of, display, and perform such User Content through the App. You hereby irrevocably waive any claims and assertions of moral rights or attribution with respect to your User Content.

6. Intellectual Property

All content, trademarks, and logos on the App are the property of VibeLink Enterprises Inc. or its licensors and are protected by intellectual property laws.

7. Data Ownership

You retain ownership of your personal information and any content you create or upload to the App (“User Data”). VibeLink Enterprises Inc. does not acquire ownership of your personal information or User Data merely because you use the App. By using the App, you grant Vibelink Enterprises Inc. a limited, non-exclusive, worldwide, royalty-free license to host, store, process, transmit, display, and otherwise use User Data to the extent reasonably necessary to operate, maintain, secure, improve, support and provide the App and services, and as otherwise described in our Privacy Policy.

Vibelink may create and use aggregated and de-identified information derived from User Data for analytics, service improvement, research, product development, security, and other legitimate business purposes, provided that such information is processed so that it does not reasonably identify you as an individual. VibeLink may retain and use properly de-identified and aggregated information indefinitely or for as long as permitted by applicable law.

VibeLink does not offer personal information as a standalone data product or provide personal information to data brokers. However, VibeLink may disclose certain personal information to Commercial Partners in connection with your voluntary engagement with a Commercial Partner’s profile, promotion, or other promotional content, as described in our Privacy Policy and subject to applicable law and any rights or choices available to you.

Nothing in these Terms transfers ownership of your personal information to VibeLink.

8. Use of University Names and Logos and Student Organizations

University names, trademarks, logos, student organization names, and other institutional identifiers may appear on or in connection with the App for identification, organizational, discovery, or informational purposes.

Unless expressly stated otherwise, VibeLink Enterprises Inc. is not affiliated with, sponsored by, endorsed by, or acting as an agent of any university or student organization.

VibeLink will not intentionally represent that a university, student organization, or other institutional entity endorses a Commercial Partner, its products, services, promotions, or transactions unless VibeLink has received appropriate authorization to make such representation.

Where VibeLink facilitates discovery or introductions involving a university or student organization, the relevant university or organization may have its own policies, approval requirements, sponsorship rules, trademark requirements, or other conditions governing interactions with outside businesses. Users and Commercial Partners are responsible for complying with those requirements.

9. Commercial Partners and Promotional Content

The App may include profiles, promotions, advertisements, offers, links, or other content provided by businesses and other commercial organizations (“Commercial Partners”). VibeLink will not provide a Commercial Partner with unrelated student information merely because the student has an account on the App. Commercial Partner access to personal information is subject to applicable law, the student’s available privacy choices, and the restrictions described in these Terms and our Privacy Policy.

Commercial Partners are independent third parties. VibeLink does not endorse, guarantee, or assume responsibility for any Commercial Partner, its products or services, its representations, its promotional materials, or any agreement, transaction, sponsorship, employment opportunity, purchase, or other relationship that may arise between a Commercial Partner and a student or student organization.

VibeLink does not negotiate or enter into agreements on behalf of students, student organizations, Commercial Partners, or universities; does not process payments between them; does not receive commissions based on transactions between them; and does not act as a broker, agent, representative, or party to any subsequent transaction.

You are responsible for evaluating any Commercial Partner and its products, services, offers, representations, and communications before engaging with or relying upon them.
